ARTICULATION AGREEMENT BETWEEN WHARTON COUNTY JUNIOR COLLEGE AND TEXAS WOMAN'S UNIVERSITY

This Articulation Agreement ("Agreement") is made by and between Wharton County Junior College ("Wharton"), a junior college district in the State of Texas, and Texas Woman's University ("TWU"), an institution of higher education in the State of Texas, on behalf of its College of Nursing.

Wharton and TWU are mutually committed to educating, graduating, and preparing more students to join the nursing workforce in the Texas Upper Gulf Region. This Agreement applies to students enrolled in Wharton's Associate Degree in Nursing Program ("ADN"), upon the execution date of this Agreement.

I. Purpose

The Agreement establishes a Blended Nursing Program, between Wharton and TWU, and facilitates the transfer and degree completion process for Wharton's ADN students that concurrently pursue the Bachelor of Science in Nursing Degree (BSN) at TWU. This Agreement outlines the roles and responsibilities of Wharton and TWU. Nothing in this Agreement shall restrict or limit either party from entering into a similar contract, with respect to the subject matter hereof, with a third party.

II. Term and Termination

This Agreement will commence on August 1, 2023 (the "Effective Date") and continue until May 31, 2028 (the "Termination Date") or until either party provides written notice of termination to the other party, at any time and for any reason, with no less than six (6) months written notice. This Agreement shall not automatically renew; instead, upon mutual written consent of the parties, the parties may renew this Agreement in whole or in part, for a mutually agreed upon period, at any time prior to the Termination Date. Should notice of termination be given under this section, then Wharton's ADN students in good standing at TWU, as determined solely by TWU, will be allowed two (2) full calendar years to obtain a BSN degree from TWU, under the same terms as if this Agreement was still in place.

III. Scope

- a. Students covered under this Agreement shall be subject to all applicable student code of conduct policies, used by both parties. This includes institution wide student conduct policies and nursing related student conduct policies, at both parties.
- b. To be eligible for the Blended Nursing Program, a Wharton ADN student must:
 - Successfully complete Wharton's general education prerequisite courses, with a 3.0 cumulative grade point average on a 4.0 scale;
 - Concurrently be taking Wharton's ADN courses, with a 3.0 cumulative grade point average on a 4.0 scale in those ADN courses;
 - iii. Properly submit: an Apply Texas Application, a TWU College of Nursing application, and payment of all applicable fees; and
 - iv. Satisfy TWU admission requirements, including TWU's: Registered Nurse (RN) to BSN bridge program admission requirements, general education requirements, and pre-nursing requirements.
- c. If a Wharton ADN student successfully satisfies all conditions under Section III.b. of this Agreement, then TWU shall accept up to 28 SCH advanced placement basic nursing courses and up to 56 SCH general education/core courses. TWU's acceptance of courses shall be governed by TWU's policies and procedures, and done in accordance with Exhibit 1 and its appendices contained therein and attached hereto.

d. Readmission:

- i. If a Wharton ADN student enters the Blended Nursing Program and voluntarily discontinues after completing any TWU BSN course, while still in good standing at TWU as determined solely by TWU, then if that Wharton ADN student:
 - 1. Graduates from Wharton's ADN program;
 - 2. Passes the National Council Licensure Examination (NCLEX); and
 - 3. Applies and is admitted to TWU's RN to Bridge Program within one (1) calendar year of the student's graduation from Wharton's ADN program;
 - Then, TWU may apply credit, consistent with TWU's transfer policy, from that student's course grades in the Blended Nursing Program towards that student's RN to Bridge Program's course requirements at TWU.

IV. Wharton's Responsibilities:

- Designate an employee within the ADN program, to serve as a liaison for students interested in pursuing the BSN at TWU.
- Encourage students to work closely with their academic advisor to develop an academic plan to ensure a successful transition to TWU.
- c. Prepare its students to take and pass the National Council Licensure Examination (NCLEX).

V. TWU's Responsibilities:

- Designate an employee within the TWU's College of Nursing program to serve as a liaison for students interested in pursuing the BSN at TWU.
- b. Evaluate applications on the basis of the student's academic record, including cumulative grade point average, performance trends, and performance in courses related to Nursing.
- c. Establish and maintain a concurrent admission process whereby Wharton's current ADN students may receive provisional acceptance to the RN to BSN program at TWU, if the Student:
 - i. Declares an intent to seek a BSN from TWU;
 - ii. Completes a Declaration of Intent with both parties; and
 - iii. Satisfies TWU admission and eligibility requirements.

VI. Wharton and TWU's Joint Responsibilities:

- a. The parties will provide information about the Blended Nursing Program on their respective websites.
- b. In the spirit of articulation, employee representatives from both institutions shall confer at least annually to evaluate the success of this Agreement, to consider curriculum updates, and to discuss changes that may enhance and strengthen this collaboration.
- c. Pursuant to applicable law, the parties shall share aggregate information on student performance as may be necessary to evaluate the success and quality of the services under this Agreement.

- d. Maintain separate and independent accreditation by the Southern Association of Colleges and Schools, and appropriate nursing accreditation bodies.
- e. Inaugurate a prescribed curriculum and sequence of courses as agreed by a collaboration of the respective programs. Coordinate any changes to curriculum and sequence of courses, and effectuate said changes via an amendment to this Agreement, signed by both parties. Amendments may take the form of letters signed by the party's designated representatives.
- f. Strive to provide students with "seamless" access to assist them in transferring from Wharton to TWU.
- g. Identify an operations contact person to assist in addressing student/advising questions and help resolve project logistical issues that may develop.
- h. Require that students be in good standing, including meeting academic and professional standards as defined by each institution to remain in the program.

VII. Intellectual Property

Each party acknowledges that all rights in any trademarks, service marks, slogans, logos, designs, and other similar means of distinction associated with that party (its "Marks"), including all goodwill pertaining to the Marks, are the sole property of that party. Neither party may use the Marks of the other without the advance written consent of that party, except that each party may use the name of the other party in factual statements that, in context, are not misleading.

VIII. Relationship between Parties

Nothing in this Agreement is intended to or shall be construed to constitute or establish an agency, employer/employee, partnership, franchise, or fiduciary relationship between the parties, and neither party shall have the right or authority or shall hold itself out to have the right or authority to bind the other party, nor shall either party be responsible for the acts or omissions of the other, except as provided specifically to the contrary herein. Each party shall be responsible for its own acts, errors or omissions and for the acts, errors or omissions of its employees, officers, officials, agents, and boards, and shall be responsible for any losses, claims, and liabilities that are attributable to such acts, errors, or omissions, including providing its own defense, arising out of this Agreement.

IX. Assignment

This Agreement shall not be assigned by either party without the prior written consent of the other party.

X. FERPA

Pursuant to the Family Educational Rights and Privacy Act of 1974 (FERPA), to the extent that TWU and Wharton receives, generates, or maintains educational records from each other, under this Agreement, TWU and Wharton mutually designate each other as school officials with legitimate educational interest in the educational records of students covered under this Agreement. This designation is made to the extent that access to the educational records are required to carry out this Agreement. TWU and Wharton agree to maintain the confidentiality of the education records in accordance with the provisions of FERPA.

XI. Severability

The invalidity of any provision of this Agreement will not affect the validity of any other provisions.

XII. Headlines

Headlines in this Agreement are for convenience only.

XIII. Force Majeure

"Event of Force Majeure" means an event beyond the control of Wharton or TWU, which prevents or makes a party's compliance with any of its obligations under this Agreement illegal or impracticable, including but not limited to: act of God (including, without limitation, fire, explosion, earthquake, tornado, drought, and flood); war, act or threats of terrorism, hostilities (whether or not war be declared), invasion, act of enemies, mobilization, requisition, or embargo; rebellion, insurrection, military or usurped power, or civil war; contamination or destruction from any nuclear, chemical, or biological event; riot, commotion, strikes, go slows, lock outs, or disorder; epidemic, pandemic, viral outbreak, or health crisis; or directive of governmental authority. No party will be considered in breach of this Agreement to the extent that performance of their respective obligations is prevented or made illegal or impracticable by an Event of Force Majeure that arises after execution of this Agreement. A party asserting an Event of Force Majeure hereunder ("Affected Party") will give reasonable notice to the other party of an Event of Force Majeure upon it being foreseen by, or becoming known to, Affected Party. In the event of an Event of Force Majeure, Affected Party will endeavor to continue to perform its obligations under the Contract only so far as reasonably practicable.

XIV. Governing Law

This Agreement and all of the rights and obligations of the parties thereto and all of the terms and conditions thereof shall be construed, interpreted and applied in accordance with and governed by and enforced under the laws of the State of Texas, without giving effect to any choice of law rules which would refer the matter to the laws of another jurisdiction.

XV. Entire Agreement

Exhibit 1, and its included appendices, attached hereto, are incorporated herein and made a part of this Agreement, as if set forth in full. This Agreement supersedes all prior agreements and understandings, oral, written and implied, between the parties hereto with respect to the subject matter hereof. All such prior agreements and understandings are hereby terminated and deemed of no further force or effect. This Agreement contains the entire Agreement of the parties as it relates to the subject matter hereof and may be amended at any time by mutual, signed, written consent of the signatory parties, through their authorized representatives.
