Wharton County Junior College is offering its facilities for the 2024 CRDTS dental hygiene licensure examination. The Dr. Anna T. Harrison Dental Hygiene Clinic is located on the Wharton Campus; Johnson Health Occupations Center first floor at the corner of Pioneer St. and Horton Foote St. in Wharton, Texas.

Parking:

There is no repair service available for equipment the candidate brings to the site or a guarantee that such equipment is compatible with the clinic facilities. Therefore, we encourage you to use the equipment provided by our site. There is no additional charge.

WCJC will not provide the following:

Protective eye wear for candidate.
Instruments
Appropriate clinic attire
PPE – Required gloves, masks, over gowns, and face shields

Personal Protection and Infection Control:

Candidates must strictly adhere to all CDC guidelines concerning barrier protection and instrument/equipment sterilization. It is the policy of the Wharton County Junior College Dental Hygiene Program that all students/candidates wear scrubs, disposable over gowns, protective eyewear with side shields, gloves, face shield and face-masks while performing patient treatment. Each candidate is responsible for providing this equipment.

All instruments must be sterile and appropriately packaged.

Sterilization services are not available prior to or after the examination.
